# Photograph Guide for Media Covering the Presidential <u>Debate</u>

Special Collections has many photograph and film collections in its holdings, however, access to originals and copyright concerns can significantly delay our ability to meet the immediate needs of the media. In preparation for the debate, Special Collections has indentified collections whose copyright and digital accessibility will permit a more rapid turn around. The collections listed provide images of the University of Mississippi during its integration in 1962, as well as antebellum images of the campus. **Mississippi Highway Patrol Collection.** A small collection of black and white images taken by the Mississippi Highway Patrol during the integration riot on the University of Mississippi campus on September 30 and October 1, 1962.

**Edward C. Boynton Collection**. A professor at the University of Mississippi from 1856 until 1861, Boynton captured antebellum university scenes and places. The archive holds a collection of his glass plate negatives. Print copies of most of the negatives are available. **Russell Barrett Collection.** Much of the collection pertains to the integration of Ole Miss by James Meredith in September 1962 and the riots that ensued on campus and in the town of Oxford. It includes personal papers, pamphlets, reports, manuscripts, sermons, and other materials on various topics such as academic freedom on college campuses and the civil rights movement in Mississippi. As an inducement to and partial consideration for Special Collections, University of Mississippi Libraries ("Special Collections") providing certain photographs, copies, or reproductions ("materials"), the undersigned ("applicant") agrees and consents to the following terms and conditions:
